

# ROLLING RICHES SWEEPSTAKES RULES

**NO PURCHASE OR PAYMENT NECESSARY TO PARTICIPATE. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE THE CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.**

**PLEASE BE AWARE THAT THESE SWEEPSTAKES RULES ENCOMPASS SECTION 23 OF THE ROLLING RICHES TERMS AND CONDITIONS, WHICH CONTAIN A PROVISION THAT RELINQUISHES THE ABILITY TO ENGAGE IN ANY CLASS, GROUP, OR REPRESENTATIVE CLAIMS, MANDATING THE RESOLUTION OF PRIOR, ONGOING, AND FORTHCOMING DISPUTES BETWEEN THE PARTICIPANT AND US VIA INDIVIDUAL ARBITRATION, UNLESS THE PARTICIPANT CHOOSE TO OPT OUT WITHIN THE DESIGNATED TIMEFRAME. FOR ADDITIONAL DETAILS, REFER TO SECTION 11 IN THESE SWEEPSTAKES RULES.**

The Sponsor/Promoter of the Sweepstakes is Rolling Riches Ltd. ("Rolling Riches"), an internet-based Platform that provides Participants with the opportunity to engage in entertaining and enjoyable gaming experiences. Additionally, Rolling Riches offers Participants entries into sweepstakes using "Sweepstakes Coins" as detailed in the Sweepstakes Rules outlined below. These Sweepstakes Coins can be utilized to partake in promotional gaming sessions, offering Participants the chance to acquire more Sweepstakes Coins that can be redeemed for Prizes and hold a monetary value of 1 Sweepstakes Coin being equal value to one dollar.

Your Participation in the Rolling Riches Sweepstakes is subject to these official rules, which are part of the Rolling Riches Terms and Conditions. These Sweepstakes Rules are not meant as a replacement or new agreement.

It is important to note that these Sweepstakes Rules should be reviewed alongside the Rolling Riches Terms and Conditions ("T&Cs"). Any terms defined in the T&Cs hold the same significance within these Sweepstakes Rules.

## 1. ELIGIBILITY TO PLAY ROLLING RICHES

(1) The following definitions are applicable to these Sweepstakes Rules:

- a. "Eligible Participants" refers to individuals who are legal residents of the "Permitted Territories."

- b. "Permitted Territories" encompass the United States (excluding Hawaii, Idaho, Kentucky, Michigan, Nevada, and Washington states, and other territories prohibited by law).
- c. A "Participant" is defined as an individual who takes part in "Promotional Play."
- d. "Postal Request Code" carries the meaning as outlined in Section 2(4) within these Sweepstakes Rules.

**(2)** "Promotional Play" denotes sweepstakes promotions hosted by Rolling Riches. It is open solely to "Eligible Participants" who are either at least eighteen (18) years old or have reached the age of majority in their respective jurisdiction. Some jurisdictions require Participants to be at least the age of nineteen (19) years old at the time of entry. **PARTICIPATION IS VOID WHERE PROHIBITED BY LAW.**

**(3)** Participation signifies the "Participant's" complete and unconditional acceptance of these Sweepstakes Rules and the decisions made by Rolling Riches, which are considered final and binding in all matters associated with the Sweepstakes.

**(4)** Sweepstakes are governed by all pertinent federal, state, provincial, territorial, and local laws and regulations. It remains the sole responsibility of each "Participant" to ascertain whether the Sweepstakes are lawful and comply with all regulations in their residing jurisdiction.

**(5)** Winning a Prize and the Redemption of a Prize is contingent upon meeting all requirements outlined in these Sweepstakes Rules.

**(6)** Employees of Rolling Riches, their respective affiliates, subsidiaries, holding companies, advertising agencies, or any other entities or individuals involved in the planning, production, execution, or distribution of the Sweepstakes, along with their immediate family members (spouse, parents, siblings, and children, whether related by birth, marriage, or adoption), and household members (those who share the same residence for at least three months of the year), are ineligible to participate.

## **2. HOW TO OBTAIN Sweepstakes Coins**

**(1)** In order to participate, an active Customer Account is required. If the participant doesn't have one, the participant can create a Customer Account at no cost by visiting <https://www.rollingriches.com>. To enter the Sweepstakes, Participants must access the Rolling Riches website at <https://www.rollingriches.com> and log in to their Customer Account.

**(2)** Upon accessing Rolling Riches, there are four potential methods for Eligible Participants to collect Sweepstakes Coins:

- a. Receive Sweepstakes Coins as a complimentary gift when purchasing Gold Coins. Each Participant may be given Sweepstakes Coins as a free gift when buying specific packages of Gold Coins that are clearly marked. Gold Coins are intended for social Gameplay on the Rolling Riches Platform and cannot be exchanged for Prizes or other monetary value. The quantity of Sweepstakes Coins given away as a gift for each specific Gold Coin purchase will be specified in the website's purchase window. All Gold Coin purchases are final, and Rolling Riches is not required to issue any refunds for any reason.
- b. Receive Sweepstakes Coins by participating in no-cost Sweepstakes Coins giveaway promotions on Rolling Riches social media channels. Rolling Riches regularly organizes Sweepstakes Coins giveaway promotions, which Participants can engage with by following the promotion's provided instructions. These giveaways may involve actions like sharing social media posts or answering questions to qualify for the giveaway. The amount of Sweepstakes Coins to be given away will be indicated in the relevant Sweepstakes Coins no-cost promotion post and will be credited to the Customer Account of each promotion winner.
- c. Collect Sweepstakes Coins through account login. Participants can collect complimentary Sweepstakes Coins daily by following these steps (Daily Bonus/Gift):
  - i. Log in to participant Customer Account.
  - ii. If eligible, a pop-up screen will appear, allowing the participant to claim the Hourly Bonus/Gift.
  - iii. Click the "Claim" button located at the bottom of the Hourly Bonus/Gift pop-up window.

Participants are permitted to claim the Hourly Bonus upon log-in once every six (6) hours.

- d. Collect Sweepstakes Coins via postal request. Participants can receive free Sweepstakes Coins by obtaining a Postal Request Code and sending a standard postcard or a sheet of white paper ("Request Card") that must measure 4" x 6" and remain unfolded. Place this Request Card inside a stamped #10 envelope. The request shall be handwritten in blue or black ink, and sent to the following address while fulfilling the specified requirements:

Participants must:

i. Handwrite their return address on the front of the envelope along with their name, as shown on government issued identification.

ii. Handwrite all of the following on only one side of the Request Card inserted inside the envelope:

A. Top left of the card, in the following order:

- One (and only one) unique one-time Postal Request Code (Sections 2(4) and 2(5) of these Sweepstakes Rules for further information);
- Their full name as shown on their government issued identification;
- The email address registered to their Rolling Riches account;
- The return/residential address registered to their Rolling Riches account; and
- The Date the postal code was requested.

B. Write the following statement on the card:

- Above the following statement, write the heading "Sweepstakes Request".
- "I am submitting this postcard to enter the Rolling Riches Sweepstakes and receive three Sweepstakes Coins. By entering, I acknowledge that I have read, agree, and understand that I am bound by The Rolling Riches Sweepstakes Rules and Terms and Conditions."

**(3)** For Postal Requests, a single outer envelope can contain only one Request Card (multiple requests in one envelope will render all requests invalid).

**Effective January 1, 2024**, for each Request Card that a Participant submits in accordance with the aforementioned criteria, postmarked after this date, they will receive three (3) Sweepstakes Coins, which will be promptly added to their Customer Account. **PLEASE NOTE: Participants must ensure that their handwriting is clear and legible.** In cases where the Participant's handwriting is not legible, the entry will be considered void, and the Sweepstakes Coins will not

be credited to the Participant's Customer Account. The determination of the legibility of a Participant's handwriting rests solely with Rolling Riches.

**THE REQUEST MUST ORIGINATE SOLELY FROM THE PARTICIPANT AND BE MAILED FROM THE SAME STATE OR PROVINCE AS THE PARTICIPANT'S VERIFIED RESIDENTIAL ADDRESS.** Requests made by any other individual or entity (including, but not limited to, commercial sweepstakes subscription notifications and/or entry services) or sent from a State or Province different from the Participant's verified residential address will be deemed invalid and Sweepstakes Coins will not be added to the Participant's Customer Account. Any attempt to manipulate the entry process or the Sweepstakes operation, including, but not limited to, using any device to automate the Sweepstakes Coins request/entry process, or unfairly assisting the Participant in meeting the handwriting requirement, is strictly prohibited. Requests/entries that, in the sole discretion of Rolling Riches, appear to have been submitted in this manner will be rendered null and void. In the event of a dispute regarding the identity of the individual who personally submitted a request or whether a request complies with the aforementioned requirements, if such dispute cannot be satisfactorily resolved to Rolling Riches' judgment, the affected request/entry will be deemed ineligible.

**(4)** A Postal Request Code is a unique combination of 12 digits that Participants can obtain by following the steps outlined in Section 2(5) of these Sweepstakes Rules. A Postal Request Code is unique and can only be used once. The purpose of a Postal Request Code is to assist with the efficient and effective processing of a Participant's Request Card. **A POSTAL REQUEST CODE CAN ONLY BE USED BY THE PARTICIPANT WHOSE CUSTOMER ACCOUNT WAS USED TO GENERATE THAT POSTAL REQUEST CODE.** Any Participant suspected by Rolling Riches to have directly or indirectly provided a Postal Request Code to another person may, in the sole discretion of Rolling Riches, be disqualified and lose their eligibility to Participate in the Sweepstakes.

**(5)** A Postal Request Code can be obtained by following each of these steps:

- a. sign into the participants Customer Account;
- b. select the "Postal Request Code" link;
- c. select the "Postal Request Codes" button and follow the prompts.

The Postal Request Code is then displayed for a period of time to enable a Participant to record it on their Request Card.

A Postal Request Code will expire after sixty (60) days from the date in which it was generated. After expiration, the Postal Request Code will no longer be a valid method to acquire Sweepstakes Coins as identified in Section 2(2) above.

**(6)** The quantity of Sweepstakes Coins held by a Participant will be visible within their Customer Account on the website. It is important to note that the allocation of Sweepstakes Coins to Participants may be modified at any time at the sole discretion of Rolling Riches.

**(7)** Rolling Riches assumes no responsibility for Sweepstakes Coins requests or allocations that are lost, delayed, incomplete, invalid, unintelligible, or misdirected.

**(8)** In cases of disputes regarding the registration of a Customer Account, the individual authorized to use the email address for Customer Account registration will be regarded as the Participant. The "authorized account holder" refers to the natural person assigned the email address by an internet access provider, online service provider, or other organization responsible for email address assignments related to the submitted address.

**(9)** The use of automated systems or any other mechanism(s) to participate, obtain Sweepstakes Coins, or engage in Gameplay is strictly prohibited and will lead to disqualification, rendering the participant ineligible for Gameplay.

**(10)** Sweepstakes Coins may also be forfeited in the event of a Participant's Customer Account closure for any reason or at the discretion of Rolling Riches.

**(11)** There is no limit to the amount of envelope requests that any Participant may send through this Alternative Method of Entry in order to collect free Sweepstake Coins. In agreeing to these Terms and Conditions and Sweepstakes Rules, Players understand and acknowledge that there is no purchase required to participate in the Rolling Riches Sweepstakes promotion. Players further agree and acknowledge that the odds of winning the Sweepstakes promotion are equal for all eligible Participants and waive their right to dispute this claim.

### **3. SPONSOR / PROMOTER**

The Sponsor/Promoter of the Sweepstakes is Rolling Riches Ltd., with its Registered Agent being ABM Corporate Services, Ltd., 1<sup>st</sup> Floor, Columbus Centre, P.O. Box 2283, Road Town, Tortola, British Virgin Islands.

### **4. USING SWEEPSTAKE COINS FOR GAMEPLAY**

**(1)** Participants in possession of Sweepstakes Coins can utilize them to participate in games within Rolling Riches, offering them the opportunity to win additional Sweepstakes Coins. Sweepstakes Coins collected through Gameplay

can be exchanged for Prizes that hold a monetary value of 1 Sweepstake Coin being equal to one dollar.

(2) Rolling Riches features various games, utilizing Sweepstakes Coins with minimum and maximum entry options displayed for each Game.

(3) Only winnings from Games played with Sweepstakes Coins may be redeemed for monetary value. The Prize available during Gameplay can be viewed on the Platform by clicking the "Hamburger Menu" (three horizontal lines) which will display the "Pay Table" button and is denominated as "Sweepstakes Coins."

(4) Each Sweepstakes Coin obtained through Gameplay (as opposed to other methods described in Section 2 of these Sweepstakes Rules) can be exchanged for a Prize with a value equivalent to one dollar, subject to the eligibility requirements set forth in Section 4(6) below.

(5) Decisions made by Rolling Riches regarding the management and operation of the Sweepstakes, games, and the Prize amounts are deemed final and binding.

(6) Unless stipulated otherwise by Rolling Riches, any Sweepstakes Coins allocated to a Participant must be used for Gameplay before becoming eligible for redemption for Prizes. Rolling Riches may, at its sole discretion, require that Sweepstakes Coins allocated to a Participant must be used a greater number of times (not exceeding 20) in any combination of Sweepstakes Coins Games before they can be redeemed for Prizes.

(7) Rolling Riches retains the right to modify the Prize win rates and odds for any of the Sweepstakes at any time. Participants can view the current and any revised details by clicking on the "Hamburger Menu" button (three horizontal lines). It is important to stay informed about any updates regarding the games and their associated odds. It is the responsibility of each Participant to verify the Prize win rate on each occasion before they engage in Gameplay.

## **5. VERIFICATION AND CONFIRMATION OF POTENTIAL WINNERS**

**(1) All potential Sweepstakes winners are subject to verification by Rolling Riches (in any method it deems suitable), and the decisions of Rolling Riches are definitive and binding in all matters related to the Sweepstakes. A Participant is not deemed a winner of any Prize, even if the online screen indicates so, unless and until the Participant's eligibility and the potential winning play have been verified, and the Participant has fully adhered to these Sweepstakes Rules and received notification that verification is complete. Rolling Riches will not accept screen captures or any other purported evidence of winning in place of its validation process.**

(2) Potential Prize winners must adhere to these Sweepstakes Rules, and winning is contingent upon meeting all stipulated requirements.

(3) A Sweepstakes winner may be obligated to sign and return any and all documents requested by Rolling Riches, including but not limited to a declaration of eligibility in order for them to claim their Prize.

(4) If a potential winner cannot be reached, fails to correctly complete and return requested documents by Rolling Riches of eligibility within the specified timeframe (if applicable), fails to comply with these Sweepstakes Rules, or if the Prize or Prize notification is returned as undeliverable, that potential winner will forfeit the Prize.

(5) In the event that a potential winner of a Sweepstakes Prize is disqualified for any reason, Rolling Riches may, at its sole discretion, reintroduce the Prize back into the Sweepstakes, as applicable.

## 6. PRIZES

(1) A Participant's Sweepstakes Coins balance is visible in their Customer Account.

(2) In cases where a Participant opts to redeem their Prize, payment will be disbursed to the Participant's bank account, online wallet, or other payment medium. Rolling Riches retains the right to mandate another specific payment method at its sole discretion.

(3) Rolling Riches will process a Prize redemption only if the redeemable Prize value is one hundred dollars or more (equivalent to a minimum of 100 eligible Sweepstake Coins). Consequently, a Participant's Customer Account must hold a balance of at least 100 Sweepstakes Coins (that are eligible for redemption) before requesting a Prize redemption.

(4) TO QUALIFY FOR A SWEEPSTAKES COINS PRIZE OR A SWEEPSTAKE COINS PRIZE REDEMPTION:

- a) A PARTICIPANT MUST BE AN ELIGIBLE PARTICIPANT; AND
- b) THE PARTICIPANT'S DETAILS MUST MATCH THOSE OF THE PARTICIPANT'S ACCOUNT.
- c) THE PARTICIPANT'S DETAILS MUST BE SUCCESSFULLY VERIFIED BY ROLLING RICHES.

(5) **In New York and Florida, the maximum redemption value of a Sweepstakes Coins Prize won on any single spin or play in the Sweepstakes is capped at five thousand dollars. Prizes exceeding this value will be reduced to a maximum of five thousand dollars. Rolling Riches reserves the right to remove all Sweepstakes Coins won in**

**excess of five thousand dollars at any time after the spin or play for Participants residing in, and/or playing from, New York and Florida.**

- (6) At its sole discretion, Rolling Riches reserves the right to impose a daily Prize redemption limit of one thousand dollars. The total number of Prizes redeemed will not exceed the stated quantity.
- (7) Taxes or fees associated with Prize redemptions are not the responsibility of Rolling Riches. Participants are liable for any applicable taxes and fees connected to Prize receipt and/or redemption. Rolling Riches reserves the right to issue participants a 1099-MISC form at year end in accordance with applicable US federal tax laws.
- (8) Sweepstakes Coins are non-transferable, and substitutions will only be made as outlined herein, at the sole discretion of the Rolling Riches. Rolling Riches retains the right to substitute the listed Prize with one of equal or greater value for reasons beyond their reasonable control.
- (9) Prize winners will receive notification through private message or email.

## **7. ENTRY CONDITIONS AND RELEASE**

By Participating, every Participant hereby agrees to:

- a) Comply with and be bound by:
  - i. the T&Cs,
  - ii. these Sweepstakes Rules, and
  - iii. the conclusive and binding decisions made by Rolling Riches.
- b) Release and absolve Rolling Riches Prizes, and all other entities involved in sponsoring, fulfilling, administering, advertising, or promoting the Sweepstakes. This includes all current and former officers, directors, employees, agents, and representatives of these entities, collectively referred to as the "Released Parties," from any and all claims, expenses, and liabilities. This encompasses claims related to negligence, damage to property and persons of any nature, such as invasion of privacy (under legal theories including appropriation, intrusion, public disclosure of private facts, false light in the public eye, or any other applicable theory), defamation, slander, libel, violation of the right to publicity, infringement of trademark, copyright, or other intellectual property rights, property damage, or death or personal injury arising directly or indirectly from a Participant's entry, creation of an entry, or submission of an entry, as well as participation in the Sweepstakes. It also includes acceptance or use (or

misuse) of Prizes, including any associated travel or activities, and the broadcast, utilization, or presentation of the entry.

c) Indemnify, safeguard, and exempt Rolling Riches and Released Parties from and against any and all claims, expenses, and liabilities, including reasonable legal fees, arising directly or indirectly from a Participant's involvement in the Sweepstakes, as well as a Participant's acceptance, utilization, or misuse of Prizes.

## **8. LIMITATIONS OF LIABILITY**

**(1)** To the extent permitted by law in the respective jurisdictions, the Released Parties (as defined above) shall not be held liable for:

- a) Any inaccuracies or incorrect information, whether caused by a Participant, printing errors, or any equipment or programming associated with or used in the Sweepstakes.
- b) Technical failures of any nature, including, but not limited to, malfunctions, interruptions, or disconnections in phone lines or network hardware or software.
- c) Unauthorized human intervention at any stage of the entry process or the Sweepstakes.
- d) Technical or human errors that may occur in the administration or operation of the Sweepstakes.
- e) Any injury or damage to individuals or property, whether directly or indirectly, in whole or in part, arising from a Participant's involvement in the Sweepstakes or the receipt, use, or misuse of any Prize.
- f) Stolen credit or bank cards, compromised financial accounts, Customer Account information, events associated with third party vendors, or otherwise.

**(2)** If, for any reason, a Participant's Sweepstakes Coins or winning play is confirmed to have been mistakenly deleted, lost, or otherwise damaged or corrupted, the Participant's only recourse is the replacement by Rolling Riches of an equivalent amount of Sweepstakes Coins.

## **9. PUBLICITY**

Unless prohibited by applicable law, taking part in the Sweepstakes implies each Participant's agreement to allow Rolling Riches and its representatives to utilize the

Participant's name, resemblance, image, voice, opinions, as well as their place of residence and state/province/territory for promotional purposes across all media, globally, without additional compensation, notice, or consideration.

## **10. GENERAL CONDITIONS**

(1) Rolling Riches, with or without prior notification to the Participant, maintains the right to cancel, suspend, and/or modify the Sweepstakes, its T&Cs, and/or these Sweepstakes Rules, or any portion thereof, with immediate effect. This may apply in cases where such circumstances make it unavoidable, including instances of fraud, technical malfunctions, or any other factors beyond the reasonable control of Rolling Riches that impair the fairness or proper operation of the Sweepstakes. The determination of such circumstances will be at the sole discretion of Rolling Riches.

(2) Rolling Riches retains the right, at its sole discretion, to disqualify any individual found tampering with the entry process or the operation of the Sweepstakes, or who violates these Sweepstakes Rules, any other promotional rules, or conducts themselves in an offensive or disruptive manner.

(3) Any deliberate attempt by any individual to undermine the legitimate operation of the Sweepstakes may constitute a violation of both criminal and civil law. In the event of such an attempt, Rolling Riches reserves the right to seek damages from the responsible party to the fullest extent allowed by law. Failure by Rolling Riches to enforce any provision of these Sweepstakes Rules shall not be deemed a waiver of that provision.

(4) In all other instances, Rolling Riches reserves the right to cancel, suspend, and/or modify the Sweepstakes. Any notifications regarding such cancellations, suspensions, and/or modifications will be posted on the Platform at <https://www.rollingriches.com>.

## **11. DISPUTES**

Reference is made herein to Section 23 of the T&Cs (Dispute Resolution and Agreement to Arbitrate on an Individual Basis) with the same legal authority as if it were fully detailed here. By consenting to these Sweepstakes Rules, the Participant also agrees to abide by the dispute resolution and arbitration provisions outlined in Section 23 of the T&Cs.

## **12. MISCELLANEOUS**

(1) Under no circumstances shall any Participant be entitled to seek damages for, and the Participant hereby relinquishes all claims for punitive, incidental, or consequential damages, as well as any other damages, including legal fees, except for the Participant's actual out-of-pocket expenses (i.e., expenses related to participation in this Sweepstakes). The Participant also relinquishes all claims to

have damages multiplied or increased. It's important to note that certain jurisdictions may not permit limitations or exclusions of liability for incidental or consequential damages, and therefore, the above statement may not apply to the Participant.

**(2)** All matters and questions concerning the construction, validity, interpretation, and enforceability of these Sweepstakes Rules, as well as the rights and responsibilities of the Participant and Rolling Riches regarding the Sweepstakes, are governed by and construed in accordance with the laws of the State of Nevada. This is without regard to any choice of law or conflict of law principles that would result in the application of the laws of any jurisdiction other than the State of Nevada.

**(3)** To ensure fairness and the integrity of the promotion for all Participants, Rolling Riches will address inquiries through the Customer Support form and may provide updates or communications via email or social media pages.

**(4)** Any Participant who posts or is found to be posting comments on Rolling Riches' social media page or elsewhere during the promotion that are considered bullying, spiteful, or offensive to other Participants, players, and fans of Rolling Riches, or that are directly aimed at Rolling Riches, will have their comments removed and may be disqualified from the Sweepstakes. Rolling Riches reserves the right to report such behavior to social media, and the Participant may have their social media account temporarily suspended pending an investigation.
